Scams? Beware!

I defeat most of them by ignoring them. They can be difficult to recognize.

A few times, my email address has been lifted off a Woodchuck website. I got an email from someone posing the first time as Nick Rosato. Later, I got one from Jay. Both wanted me to contact them and get them gift cards. The emails looked genuine—except the return email address of each was NOT what I had for either Nick or Jay.

So, lesson #I: Check where the email came from. If it isn't familiar, ignore the email. Don't answer it or you may get trapped into another string of scams.

Another type of scam is disguised as a company you deal with. My latest trap was from Amazon. The email had the Amazon trademark slash, and was set up looking very genuine and important. Essentially, it told me that there was something wrong with my account and I needed to follow the link in the email to set things straight.

The wisdom from several sources is to NOT use that link. If the email does raise your concerns, use your own, stored link to the company and make sure your info is correct.

I was surprised to get a phone call from someone pretending to represent Amazon. They said that there was a charge of \$77.75 on my Visa card and I should contact them if I did not know about the charge. They gave me an area=coded phone number. First, I do not have an active Visa card. Second, I'm pretty sure a big company would have an 800- number for that type of transaction.

Warning bells! I did follow up by checking my account info on Amazon. I did not see anything suspicious.

There are many other robocalls to beware of. If it sounds suspicious, leave it alone. Your best defense is to look at the caller ID and not answer your phone if you do not recognize the caller. If you do answer on any call, do not say "Yes" as that response can be recorded and used to start the scam rolling.

Fake calls can mimic the IRS, Social Security, or a relative. The last one is really insidious. A neighbor got a call supposedly from a grandson who was arrested and needed a big cash bond, available through Western Union. He was fooled enough to go to his bank and ask for the cash. Fortunately the teller recognized the scam and set the neighbor straight before any harm was done.

Another scam to be alert for is a call from Microsoft or others pretending to be a computer service company. They might tell you that they have found

suspected troubles on your computer. Give them access and they will "fix" the problem. Hang up on them immediately. How can a big company like Microsoft or Dell get into every computer and find problems? If you did not call them for help, it's a scam.

The other day, I was reading through the posts on my internet home page. One looked very interesting and topical. I clicked on it and instead of getting to the article, a big red warning came up saying that I had gone to a dangerous website and not to proceed further. I didn't. obviously, my spyware software intervened.

My main firewall protection is Norton 360. It screens all my internet traffic. It does not screen my email traffic, as any malware is called up only when I follow a link to it.

I also get ads daily from health-related and insurance companies. They all have an "unsubscribe" option which I usually go to. I just wonder if that option puts me on more lists which I don't want to bother with.

It is a dangerous world out there. I have opportunities daily to get trapped, both by phone and by fiends in the cyber world. I strongly suggest that you invest in anti-spyware software. If you don't have caller ID, get it. Pay attention to it. Verify any contacts and don't give out any personal info to anyone who demands it.

I'm not paranoid, I'm just careful.

I am still working to learn how to use my carbide tools and I am not going to abandon my tool-steel gouges. Today, I am working on a yarn bowl for Cil. This one is from green Yellow Birch. I have it hollowed out and stored in a plastic bag so it dries slowly. Most of the turning has been with my Woodpecker tools. When it was time to gouge out the bottom, I switched to my Hunter deep hollowing carbide tool. The bit is about I/4 "across. It is VERY aggressive. Cleaning out the bottom inch with that tool took just a few minutes. One thing about the carbide tools: It is hard to do a gentle, smooth cut with them. I will let you know if I find a technique which makes carbide equal to traditional gouging.

I better get back to work.



Brad's work focuses on products that can be used in the home. The items range from shaving brushes and shavers, bowls, platters, and pepper mills to an assortment of smaller goods, including utensils, tools, pens, and bottle stoppers. He enjoys knowing that his turnings have been bought by people from around the globe and exist on every continent except Antarctica. His first magazine article appeared in the November 2019 issue of Woodturning FUNdamentals published online by the AAW.

Demonstrations

Turning a Pepper Mill

Learn the steps for making a pepper mill, from a 3×3 blank to a working product. You will see several types of kits that are available on the market and learn how to select your wood. We will start with roughing out the blank, then drill the various holes while mounted on the lathe and part the blank in two. Once the blank is parted, we will show how to join the parts together again using calipers and a parting tool. Then the discussion will move to shape options, sanding methods, finishes, trouble shooting and answering any questions that arise along the way. Since the process can take longer than the allotted time, the mill's final shape and assembly will not be demonstrated, but will be included in the discussion.
